**Description of
Violation**

Section 508: Violations of University Policies (Note: This is listed as Section 509 in the outline of the procedural code, but Section 508 in the body of the procedural code, so we will refer to it as Section 508)

It was brought to our executive ticket's attention at 11:38pm on Thursday March 28th, 2019 that a member of [REDACTED] who supports and was campaigning for the Vision ticket was harassing a member of the Bridge IU team via text messages (please see attached documents). In addition to these messages, our team member stated that this [REDACTED] member had previously approached [REDACTED] at the Indiana Memorial Union, following a [REDACTED] meeting. The individual said insulting comments, directed at [REDACTED] personally and the Bridge IU team, that were intimidating and lacked integrity for someone working for a campaign, that is also a [REDACTED]. This [REDACTED] bragged to our team member on Thursday March 28th, that [REDACTED] was harassing people by following them until they would take a flyer and voted for Vision. The Bridge IU team believes that this is a violation of the *Code of Student Rights, Responsibilities, & Conduct, under Section H: "Be responsible for their behavior, and respect the rights and dignity of others both within and outside of the university community". Section 19 states that, "Stalking or hazing of any kind whether the behavior is carried out verbally, physically, electronically, or in written form.*

- a. All forms of stalking, including as defined in the Sexual Misconduct Policy.
- b. Hazing is defined as any conduct that subjects another person, whether physically,
mentally, emotionally, or psychologically, to anything that may endanger, abuse, degrade, or intimidate the person as a condition of association with a group or organization, regardless of the person's consent or lack of consent.

Section 508 of the Procedural Election Code states:

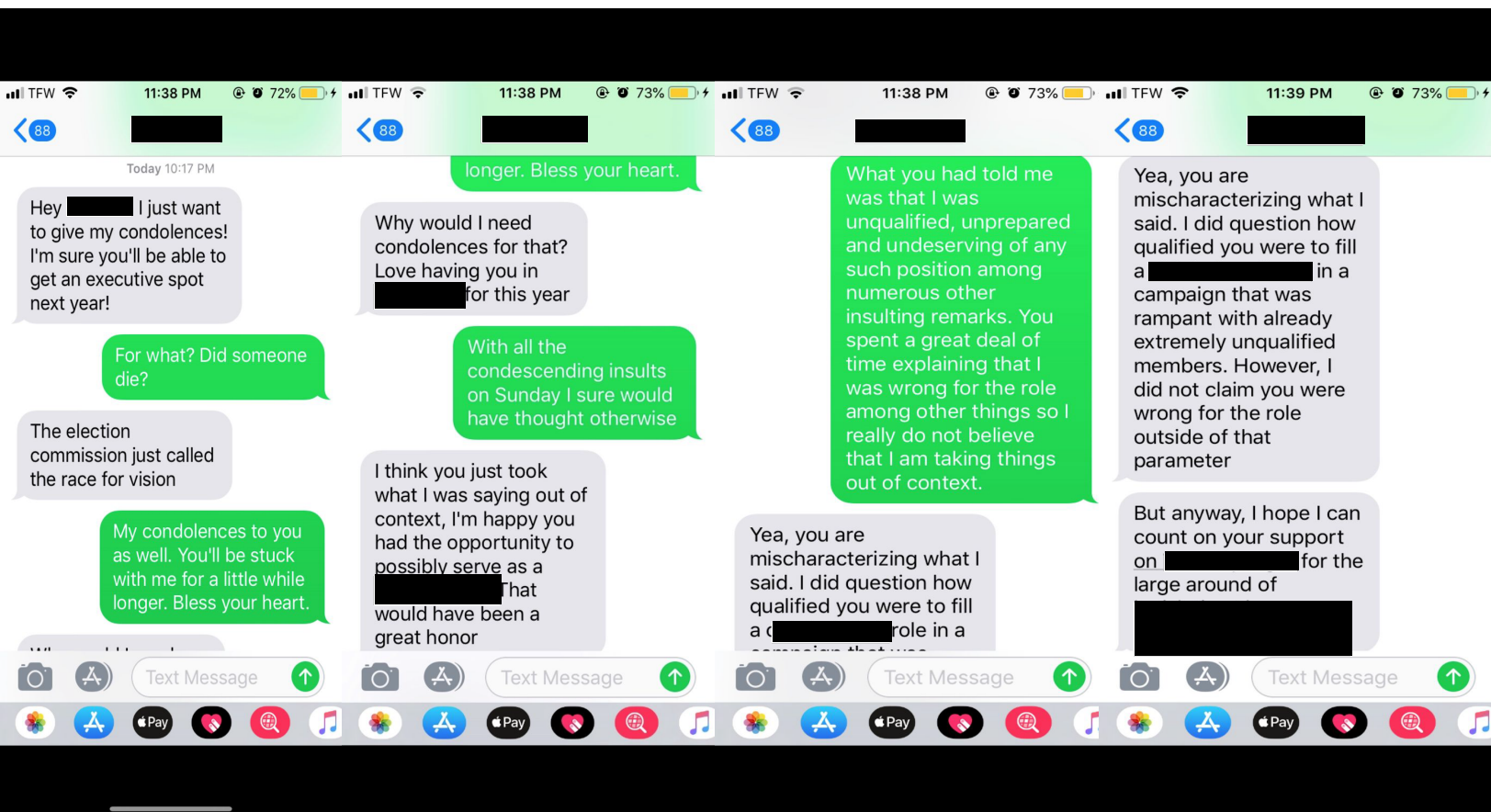
Violations of University Policies. Any ticket, candidate, or any person acting on behalf of any ticket or candidate found to have violated a publicly disseminated university policy, including the policies of the Student Life and Learning Office, University Information Technology Services (UITs), and those found in the Code of Student Rights, Responsibilities, and Conduct, for the purpose of promoting a candidate or ticket shall constitute a violation of this Code.
