Description:

Black Cabaret is a gala modeled after the National NAACP Image Awards, where we open nominations to all the students on the campus to nominate students and faculty that do amazing work but do not often get recognized. The night also celebrates black history, black IU history, and black excellence. The theme this year is "the Harlem Renaissance" celebrating the reawakening of the Black Soul. The Harlem Renaissance was the development of the Harlem neighborhood in New York City as a Black cultural mecca in the early 20th Century and the subsequent social and artistic explosion that resulted. Lasting roughly from the 1910s through the mid-1930s, the period is considered a golden age in African American culture, manifesting in literature, music, stage performance, and art which we plan to bring to life with our talents, commercial videos, and the overall show. IUSG (DEI) will be partnering with NAACP and NPHC to host this event. DEI directors will be joining their executive board in selecting talent, judges, decor, and event operations.

The Board of Finance required DEI directors Kétura Lainy and Jayanah Hammonds to submit a report outlining how they would help market, setup, and put on the event.
