## Student Body President of Indiana University Bloomington EXECUITIVE ORDER

## NO. <u>78-01</u>

## FOR: REPEALS AND AMENDMENTS TO VARIOUS EXECUTIVE ORDERS

TO ALL WHOM THESE PRESENTS MAY COME, GREETINGS:

WHEREAS,	RB § 4-2-2(a) gives me the sole power to issue Executive Orders to, among others things, implement policies and procedures for the effective administration of the executive branch;
WHEREAS,	Some of the Executive Orders issued in the administration warrant their codification in the bylaws rather than by Executive Order; and
WHEREAS,	Some of the Executive Orders are deemed to be unnecessary or prevent IUSG from being able to run effectively.

NOW, THEREFORE, I, ZACHARY GOLDBERG, by virtue of the authority vested in me as the Student Body President of Indiana University Bloomington, do hereby order that:

- 1. Executive Order 77-01 ("Establishing the Executive Registrar") shall be amended as follows:
  - a. § 2(c) is hereby repealed and all mentions of "department regulations" are hereby repealed.
  - b. § 3(c) shall be amended by striking "five business days" and insert "twenty-hour (24) hours."
  - c. § 5(a), (b) shall be repealed.

- d. § 7(a) is amended by striking all and inserting "All executive orders, proclamations, and department regulations shall be submitted to the Recorder of Congress attesting its filing and then submitted to the Department of Records for processing.
- e. § 7(c) is amended by striking "five business days" and insert "twentyfour (24) hours."
- f. § 10(d) is added to read as follows "The Department of Records is responsible for maintaining one document with all Executive Orders, Executive Proclamation, and Executive Regulations, containing all upto-date revisions as made from time to time."
- 2. The Recorder of Congress is hereby ordered to create new foundational documents of EO 77-00 and EP 77-00 within thirty (30) calendar days from issuance of this Executive Order.
- Congress shall work to codify EO 77-01 to the greatest extent applicable and make any and all necessary amendments. As such becomes codified, EO 77-01 shall be repealed.
- 4. Congress shall work to codify Executive Order 77-03 ("Expansion of the First-Year Internship Program to First-Year Transfer Students") to the greatest extent applicable, and as such becomes codified, Executive Order 77-02 shall be repealed.
- 5. Executive Order 77-07 ("Provision of Funds to Register Student Organizations") and Executive Order 77-09 ("Amendment to EO 77-07") shall be repealed.
- 6. Executive Order 77-10 ("Amendment to EO 77-07") shall be repealed.
- 7. Congress shall work to codify Executive Order 77-11 ("Establishment of EmpowerED Scholarship Program") the exact language to the greatest extent applicable, and as such becomes codified, shall be repealed.
- 8. Congress shall work to codify Executive Order 77-12 ("Establishment of Calculator Loaner Program") the exact language to the greatest extent applicable, and as such becomes codified, shall be repealed.
- 9. Congress shall work to codify Executive Order 77-13 ("The Informed Student Newsletter") to the greatest extent applicable, and as such becomes codified, Executive Order 77-13 shall be repealed.
- Executive Order 77-18 ("IUSG 2030 Strategic Plan") is amended by striking § 3(b).
