## EXECUITIVE ORDER

## NO. <u>78-02</u>

## FOR: ESTABLISHMENT OF GREEK LIFE COMMITTEE (GLC)

TO ALL WHOM THESE PRESENTS MAY COME, GREETINGS:

WHEREAS, RB § 4-1-9(b) gives me the sole power to establish study commissions for a set period of time to examine into matters of importance affecting the Student Body; and

 WHEREAS, I believe it is necessary to establish a Greek Life Council to advise the Student Body President and Vice President on matters pertaining to Greek life by providing a sense of community and belonging by working directly with students to develop policy, and promote advocacy for concerns of students in or outside Greek life pertaining to the matter.

NOW, THEREFORE, I, ZACHARY GOLDBERG, by virtue of the authority vested in me as the Student Body President of Indiana University Bloomington, do hereby order that:

- 1. For the purposes of this Executive Order, the following definitions shall apply:
  - a. "Committee" refers to the Greek Life Committee herein established.
  - b. "Executive departments and agencies" include all branches of the Indiana University Student Government and relevant administrative offices of Indiana University.
- 2. There is hereby established the Greek Life Committee ("the Committee").
  - a. The Committee shall be a standing committee for the purpose of advising on Greek Life updates, concerns, needs, and potential

advocacy. The council will also assist in policy development, fostering community, and promoting advocacy and efficiency.

- 3. The Committee shall comprise of the following members:
  - a. Two (2) voting members from each Greek Council including:
    - i. The Interfraternity Council;
    - ii. Multicultural Greek Council;
    - iii. National Panhellenic Council;
    - iv. Panhellenic Association; and
    - v. The Student Body Vice President or their designee.
  - b. Membership is also open to registered Greek organizations and houses, with each organization or house represented by their president or a designated voting member upon application to sit on the council.
- 4. The Student Body President and Vice President or upon their direction, the Chief of Staff may convene meetings of the Committee.
- 5. The Student Body President or their designee shall appoint a chair to preside over the meetings of the Committee. In their absence, a designated representative will preside.
- 6. The principal functions of the Committee are:
  - a. To advise the Student Body President and Vice President on matters pertaining to Greek life on campus;
  - b. To assist in the development of informed policies that address the needs and concerns of affected students; and
  - c. To promote advocacy for safe practices across the IU Bloomington campus.
- 7. The Committee shall have the authority to establish subcommittees, task forces, or working groups as needed to fulfill its functions.
- 8. The Committee may function through established or ad hoc committees, task forces, or working groups.
- 9. The Committee shall have a staff to be headed by the Student Body Vice President, or their designee. The Committee shall have such staff and other assistance as may be necessary to carry out the provisions of this order.
- 10. All student government departments and university administrative offices shall cooperate with the Committee and provide such assistance, information, and advice to the Committee as the Committee may request, to the extent permitted by law.
