## EXECUTIVE ORDER

FOR:

ESTABLISHMENT OF THE SHARED GOVERNANCE COMMITTEE (SGC)

TO ALL WHOM THESE PRESENTS MAY COME, GREETINGS:

WHEREAS,

RB § 4-1-9(b) gives me the sole power to establish study

commissions for a set period of time to examine into matters of

importance affecting the Student Body; and

WHEREAS,

I believe it is necessary to establish a Shared Governance Committee to advise the Student Body President and Vice President on matters pertaining to campus-wide issues, provide a sense of community and belonging by working directly with students to develop policy, and promote advocacy directly for all respective schools at IU.

NOW, THEREFORE, I, ZACHARY GOLDBERG, by virtue of the authority vested in me as the Student Body President of Indiana University Bloomington, do hereby order that:

- 1. For the purposes of this Executive Order, the following definitions shall apply:
  - a. "Committee" refers to the Shared Governance Committee herein established.
  - b. "Executive departments and agencies" include all branches of the Indiana University Student Government and relevant administrative offices of Indiana University.

- 2. There is hereby established the Shared Governance Committee ("the Committee").
  - a. The Committee shall be a standing committee for the purpose of advising the Student Body President and Vice President on matters pertaining to campus-wide issues, provide a sense of community and belonging by working directly with students to develop policy, and promote advocacy directly for all respective schools at IU.
- 3. The Committee shall comprise of the following members:
  - a. The Student Body President, and a member from each:
    - i. Respective student government on campus of each school at Indiana University Bloomington;
    - ii. School, for schools that do not have a school student government; and
    - iii. A member of the Residence Hall Association (RHA).
- 4. The Student Body President and Vice President or upon their direction, the Chief of Staff may convene meetings of the Committee.
- 5. The Student Body President shall appoint a chair to preside over the meetings of the Committee. In their absence, a designated representative will preside.
- 6. The principal functions of the Committee are:
  - a. To advise the Student Body President and Vice President on matters pertaining to campus-wide issues;
  - b. To provide a sense of community and belonging by working directly with students in every school;
  - c. To develop policy and promote advocacy directly for all respective schools at IU.
- 7. The Committee shall have the authority to establish subcommittees, task forces, or working groups as needed to fulfill its functions.
- 8. The Committee may function through established or ad hoc committees, task forces, or working groups.
- 9. The Committee shall have a staff to be headed by the Student Body Vice President, or their designee. The Committee shall have such staff and other assistance as may be necessary to carry out the provisions of this order.
- 10. All student government departments and university administrative offices shall cooperate with the Committee and provide such assistance, information, and advice to the Committee as the Committee may request, to the extent permitted by law.
